Fire destroyed part of the building valued Ksh 3,200,000. Calculate how much each will get as compensation. Give a reason for your answer. (4marks)

Compensation = (value of the policy  $\div$  value of property)  $\times$ loss

 $(Ksh 5,600,000 \times Ksh 3,200,000) \div ksh 6,400,000 = ksh 2,800,000$ 

Ratio of Natasha to Cynthia = 1,600,000 : 4,800,000

1:3

Natasha got  $\frac{1}{4} \times 2,800,000 = \text{ksh } 700,000$ 

Cynthia got  $\frac{3}{4} \times 2,800,000 = \text{ksh } 2,100,000$ 

Reason; the property was under-insured hence the loss is shared between the insurer and the insured.


- 11. Highlight any **four** measures that the government has taken to reduce road carnage on the Kenyan roads. (4marks)

**Required;** Determine Sulimos' initial capital as at 1.1.2024. (4marks)




